Meeting of the Circle Executive Committee

We are happy to inform all our members that on 27th December,2017, a meeting of the Circle Executive Committee was held at the Union Office, LHO, Guwahati at 4.00 P.M.

In the morning on that day, there was a Circle Consultative Committee Meeting where management side was represented by the Chief General Manager, General Manager Network II, DGMs (B&O) of Jorhat, Shillong, Guwahati, DGM & CDO, AGM (HR) and Chief Managers (HR) of all modules as well as Engineer and other officials. Association side was represented by the Circle Executive Committee members lead by our Circle President and General Secretary. Prominent issues like recruitment of bank guards, acute shortage of clerical staff, establishment of dispensary at Administrative Offices at Dibrugah and Silchar along with appointment of doctors and pharmacists, establishment of diagnostic centres at District head quarters, delay in sanctioning of Ex-gratia lump sum amount, payment of overtime for cash in-charge for ATM cash replenishment on Sundays and holidays, establishment of a Staff Transit camp at Guwahati and other issues concerning our staff.

In his deliberations, General Secretary elaborated upon, in details, the shortage of clerical staff in the circle. He presented the data that as on 31st October, 2013, our circle was having a clerical staff strength of 5056 while at present the same has come down to about 4000. Whereas during this period 122 new branches/offices were opened in the circle. The Chief General Manager responded positively and informed that the issue has been taken up with Corporate Centre for special recruitment of one thousand clerical vacancies in the circle. In other issues also the management responded positively.

In our Circle Executive Committee Meeting, discussions were held on organisational matters and need for strengthening the organisation was suitably emphasized.

On the eve of his superannuation from Bank, Com. Gunagobinda Sarmah, DGS Jorhat Module was extended a warm felicitation in the meeting.

The Circle Executive Committee has taken the following decisions to be effective from **1st January, 2018**.

- 1. Death benefit to be increased from Rs.10000.00 to Rs.20000.00**
- 2. Retirement benefit to be increased from Rs.2000.00 to Rs.3000.00 and**
- 3. One time financial assistance of Rs.50,000.00 to our members and their dependant family members who will undergo any one of three transplantations i.e. Kidney, Liver and Heart.**

We believe that above decisions are a step forward towards our endeavor for the welfare of our members.

We wish all our members and their families a very happy and prosperous New Year 2018.
